

ProspectSV Pioneer Membership

This ProspectSV Pioneer Membership is effective for a period of 12 months from the active date.

Definitions

"Member" is defined as the member company, not an individual employee, investor or associate of the member company. Under the terms of this agreement, Prospect Silicon Valley (hereinafter referred to as Company) will provide the following services to the Member.

"Member POC" is a single point of contact at Member company who will be responsible for initiating requests for member services and communicating with ProspectSV.

"Company" refers to Prospect Silicon Valley, also referred to as ProspectSV.

"Active Date" is the date on which payment for annual Pioneer Membership is received. Member benefits are available beginning on the Active Date.

"Subject Matter Expert (SME)" is a member of the ProspectSV staff, or an advisor engaged by ProspectSV, who has domain expertise in advanced mobility, energy and/or the buildings.

A "Company Event" is an event that is organized by ProspectSV, whether or not it takes place at ProspectSV facilities. It does not include events organized by other entities that may take place at ProspectSV facilities.

Phone Consultation

Company will provide Member a one-time 60-minute individual phone consultation with a Company subject matter expert (SME). Member is responsible for requesting the consultation. Member must submit request via email to info@prospectsv.org. Company will make reasonable efforts to accommodate Member's request for a specific SME and to accommodate schedules. SME designation is at Company's sole discretion.

Single Point of Contact

Member must designate a single point of contact (POC) at Member company, who will be responsible for initiating requests for member services (e.g. consultation, conference room reservations, requests for introductions). Member may change the designated point of contact at Member's discretion by email notification to the Company.

Free Admission to Events

Member shall receive one free admission to Company's annual symposium and two free admissions to all other Company Events.

Ecosystem Introductions

Upon request by Member POC, Company will make introductions to other startups, corporate, public sector and other partners in Company's ecosystem. Introductions are limited to one per month. Member POC will email the Company SME a short paragraph

describing the reason for the introduction request, including any necessary background information. Company SME will first ensure that ecosystem contact is receptive to being introduced to Member and will then make the connection. Requests for introductions are limited to one per calendar month. If a contact has indicated that they are not receptive to the requested introduction, this nevertheless counts toward the limit on monthly introductions.

Use of Conference Rooms

Member may request use of a Company conference room for one meeting (up to 2 hours in length) each calendar month during Company's regular business hours. Company conference rooms are located at 1608 Las Plumas Avenue, San Jose, California. To reserve a conference room, Member POC must email info@prospectsv.org with the following information:

- Date/time requested
- Expected number of meeting participants
- Room setup requirements

Company will confirm reservation or notify Member if appropriate room is not available at requested time/date. Room reservations are subject to availability.

Consideration for Grant Projects and Proposals

Member will be considered as a participant in grant-funded projects or grant proposals led by Company. Company will notify Member of relevant grant opportunities.

Occasional Notices of Startup Opportunities

From time to time, Company is made aware of opportunities for startups offered by Company's partners. Such opportunities may include, but are not limited to opportunities to exhibit products, speak at conferences or investor pitch events, apply for services or funding, or other relevant opportunities.

Member Listing on Prospect Silicon Valley Website

Member logo, link to Member website and one-sentence description of Member company will be included on Prospect Silicon Valley website. Materials must be emailed to info@prospectsv.org. Logo image must be hi-resolution jpg, png or eps format.

Monthly Newsletter

Member shall receive a free subscription to Company's monthly newsletter. An unlimited number of such subscriptions are available to Member's employees and associates.

Membership Fees

Membership is on an annual basis. Membership fee is \$1200 per Member. Member billing will be via invoice from Square® payment processing and will include an additional transaction fee. Member POC will receive an invoice via email from Square in the amount of \$1236.14 (which includes a transaction fee of a 2.9% + \$0.30, resulting in net fees to ProspectSV of \$1200).
